

## **Whisky'd Away Programme Terms and Conditions**

### **Terms and conditions:**

Ncn'ean is running a one-week internship from the 15th-19th July, at the Ncn'ean distillery, on the west coast of Scotland. It will provide two women with the chance to experience all sides of distilling. The internship will be unpaid but travel, accommodation and food will be provided for the entire week. To apply, entrants must be female, aged over 18, a UK resident (or with a visa to allow you to travel to Scotland), and available from the 14th-20th July inclusive (to allow for travel time). The deadline for applications Thursday, the 16th May, 219. After this date, no further entries to the programme will be permitted.

2. The 'Company' is: Ncn'ean Distillery, whose registered office is at Drimnin, By Lochaline, Morvern PA80 5XZ.
3. The 'Programme' is: for two women to complete a one-week internship at Ncn'ean Distillery from the 15th - 19th July, 2019.
4. Employees of Ncn'ean or Full Fat PR, their family members or anyone else connected in any way with the Programme or assisting with set up for the Programme shall not be permitted to enter the Programme.
5. There is no entry fee and no purchase is necessary to enter this Programme.

10. The internship will be unpaid but travel, accommodation and food will be provided for the entire week (14th-20th July, 2019)
11. Successful candidates will be contacted by email by the 20th May, 2019 if they have made it through to the second round.
12. No responsibility can be accepted for entries not received for whatever reason.

The Promoter reserves the right to cancel or amend the Programme and these terms and conditions without notice in the event of a catastrophe, war, civil or military disturbance, act of God or any actual or anticipated breach of any applicable law or regulation or any other event outside of the Promoter's control.
